The St. Mary Parish Council met on this date in Regular Session with Chairman Gabriel Beadle presiding and the following members present: Rev. Craig Mathews, Dale Rogers, Glen Hidalgo, Ken Singleton, James Bennett, Sterling Fryou, Paul P. Naquin, Jr., and Kevin Voisin. Absent were J Ina and Patrick Hebert.

The Invocation was pronounced by Mr. Rogers and the Pledge of Allegiance was led by Mr. Hidalgo.

Mr. Naquin moved that the reading of the minutes of the First Regular Meeting, January 9, 2019, be dispensed with and that the same be approved. Mr. Fryou seconded the motion, which carried.

Executive Director of Claire House, Terri M. Foulcard, 203 Foster Street, Franklin, Louisiana and Senior Clerk, Meg A. Morgan, 123 Pellerin Lane, Franklin, Louisiana appeared before the Council to announce the Claire House for Women and Children Food Drive to be held on January 26, 2019 at Claire House located at 1101 Southeast Blvd, Bayou Vista, Louisiana from 11:00 a.m. to 4:00 p.m. and at United Way in Houma, Louisiana from 12:00 p.m. to 4:00 p.m. Donations can also be made Monday through Friday from 8:00a.m. to 4:30 p.m. at the Claire House location.

Wax Lake East Drainage District Chairman, William "Billy" Hidalgo, Jr., 604 Techeview Drive, Berwick, Louisiana appeared before the Council to provide an update on the Hedgerow Subdivision Drainage Project and other future projects.

In response to several councilmen inquiries, Mr. William Hidalgo stated that the Hedgerow Subdivision project should be completed in approximately one month and that it appears only one large tree that is in poor condition will be removed.

Mr. Glen Hidalgo moved that the Parish Council, Alvin Lodrigue, Don Lance, Wayne Cantrell, Joel Miller from Miller Engineers & Associates, and legal counsel go into Executive Session for discussion of prospective litigation involving the work on the Bayou Vista Pump Station.

Parish President, David Hanagriff informed that Council of Governments will meet January 28, 2019 at 6:30 p.m. at Nicobella in Morgan City, Louisiana. He also informed that St. Mary Chamber of Commerce will present its 2019 Annual Membership Banquet on January 24, 2019 at 6:00 p.m. at Cypress Bayou Casino Hotel/Pavilion.

Mr. Hanagriff expounded on the road construction projects and the high water situation.

In response to Rev. Mathews' inquiry, Mr. Hanagriff stated that the high water would affect the Amelia area.

Rev. Mathews informed of several recent structure fires in the District 1 community that resulted in injuries and two (2) deaths and asked to keep the families and community in prayer and encourage citizens to be mindful of the danger of structure fires.

Chief Administrative Officer, Henry "Bo" LaGrange, presented his report for a two (2) week period ending January 23, 2019.

Item 1 in Mr. LaGrange's report stated, "The Coastal Protection and Restoration Authority announced that it is holding three public hearings across the coast to present the draft Annual Plan for Fiscal Year 2020 to receive public comment on the annual plan. Each hearing will begin at 5:30 p.m. with an open house featuring a CPRA Exhibit, the presentation on the draft Annual Plan and public comment session will be from 6-7 p.m. Hearing locations and dates are:  
January 29, 2019 – Lake Charles Civic Center  
January 30, 2019 – New Orleans Lakefront Airport  
January 31, 2019 – Houma Civic Center"

Item 2 in Mr. LaGrange's report stated, "The Coastal Protection and Restoration Authority has also announced that to comply with Act 570 of the 2018 Regular Session, which transferred the responsibilities of the Atchafalaya Basin Research and Promotion Board and the Atchafalaya Basin Program from the LA DNR to CPRA, the Atchafalaya Basin Annual Plan is now also incorporated in the Annual Plan and as a result, CPRA will hold two additional public hearings to present the Atchafalaya Basin Annual Plan as follows:  
Feb. 5, 2019 – Bayou Sorrel Branch Library  
Feb. 6, 2019 – Henderson Recreation Center."

Item 4 in Mr. LaGrange's report stated, "The LA Dept. of Agriculture & Forestry has written to advise that in compliance with LA R.S. 3:2364, the Office of the State Veterinarian has conducted an annual shelter inspection on December 7th, 2018. The purpose of the inspection program is to act in an advisory capacity to assist community programs in ensuring and promoting the proper treatment and well-being of animals. This program follows the minimum standard of performance for publicly operated animal shelters. The inspection determined that the old facility needed some maintenance and repair and a corrective action plan was discussed. The new facility was found to be in compliance."

Item 6 in Mr. LaGrange's report stated, "Bids have been received for the Four Corners/Ashton & Cypremort Point Road Improvements project. A total of five (5) bids were received with the low bid being that of Glenn Lege Construction, LLC, who submitted a bid in the amount of \$1,042,365.55. The engineer's estimate of probable cost for this project was \$1,175,000."

Item 7 in Mr. LaGrange's report stated, "Bids have been received for the Amelia Roadway Improvements project. A total of five (5) bids were received with the low bid being that of Huey P. Stockstill who submitted a bid in the amount of \$632,945.91. The engineer's estimate of probable cost was \$718,508.50."

Item 8 in Mr. LaGrange's report stated, "Bids for the Patterson and Bayou Vista Road Improvements project has been advertised and are scheduled to be received on February 21st, 2019."

In response to Rev. Mathews' inquiry regarding the future construction of Fire Protection District No. 11 central station, Mr. LaGrange expounded on procedures and requirements of subdividing property and providing fire hydrants.

In response to Mr. Hidalgo's inquiry regarding road work at the Bayou Boeuf Locks boat landing, Mr. LaGrange stated that patch work has been delayed due to the weather.

Mr. Voisin moved that the Public Hearing Report, January 9, 2019-5:45 p.m. and the Public Hearing Report, January 9, 2019-5:50 p.m. be approved. Mr. Bennett seconded the motion, which carried.

Rev. Mathews stated that he attended the Charter Review meeting on January 22, 2019 but a quorum was not established. Therefore, the meeting was not held. He suggested Councilmen contact Charter Review board members to encourage the importance of their attendance.

Mr. Naquin introduced the following ordinance:

**ORDINANCE NO.**

An Ordinance providing for the requirements relative to renaming of parish roadways.

**BE IT ORDAINED** by the St. Mary Parish Council:

**SECTION 1.** The St. Mary Parish Council has the power and authority to make name changes to roadways by a majority vote of the Council to ensure public safety; to honor a person, persons, group or organization; to commemorate an event; to designate a place; or upon a name change requested by persons for whatever reasons; and

**SECTION 2.** Should a name change be requested by persons, other than the Parish Council, for reasons other than public safety, the persons requesting said change shall be responsible for all costs associated with said road name change, if approved, including sign changes, costs of public notice signs, cost of certified mail, administrative changes in the Emergency 911 system, including mapping, etc.; and

**SECTION 3.** Whether by the Parish Council or by other persons, the St. Mary Parish Public Works Department shall erect signs within seven (7) calendar days after the date of introduction of an Ordinance at each end of the road or section of road to be renamed advising that an Ordinance has been proposed to rename the road or section of road and of the date, time, and location of a Public Hearing to be held prior to adoption of the proposed Ordinance; and

**SECTION 4.** The signs shall be a minimum size of 2 feet by 3 feet and shall include the following information and be in the following format:

**SECTION 5.** The St. Mary Parish Planning and Zoning Department shall mail notices to all property owners fronting on the road or section of road to be renamed. The names and addresses of all such property owners shall be obtained from the latest records of the St. Mary Parish Assessor's Office. The notices shall be mailed within seven (7) calendar days after the date of introduction of an Ordinance and shall be by Certified Mail/Return Receipt Requested. Said notices shall advise that an Ordinance has been proposed to rename the road or section of road, the proposed name change, and of the date, time, and location of a Public Hearing to be held prior to adoption of the proposed Ordinance; and

**SECTION 6.** Any Ordinances, or parts of ordinances, in conflict herewith are hereby repealed.

**SECTION 7.** This ordinance shall become effective and be in full force upon publication in the official journal of the Parish.

This ordinance having been offered and read on this the 23<sup>rd</sup> day of January, 2019; having been published in accordance with law.
