The St. Mary Parish Council met on this date in Regular Session with Chairman Dean S. Adams presiding and the following members present: Rev. Craig A. Mathews, J Ina, Rodney Olander, Scott Ramsey, Leslie “Les” Rulf, Jr., Patrick J. Hebert, James W. Bennett, Jr., Mark A. Duhon, Gwendolyn L. Hidalgo, and Kristi Prejeant Rink, M.D.

The Invocation was pronounced by Mr. Hebert and the Pledge of Allegiance was led by Rev. Mathews.

Mr. Olander moved that the reading of the minutes of the First Regular Meeting, May 13, 2020, be dispensed with and that the same is approved. Mrs. Hidalgo seconded the motion, which carried.

Consolidated Gravity Drainage District No. 2 Chairman, Lee Dragna appeared before the Council and thanked them for their support during his time served on the board.

In response to Mr. Dragna’s inquiry, Mr. Hanagriff expounded on the operation process of Consolidated Gravity Drainage District No. 2 and Gravity Drainage District No. 6 during the transition period of Consolidated Gravity Drainage District No. 2A. He also stated that he will contact bond attorney, Jason Akers, Foley & Judell, L.L.P. to submit a written statement that Consolidated Gravity Drainage District No. 2 and Gravity Drainage District No.6 can continue to operate until the transition is complete.

In response to Mr. Ramsey’s inquiry, Mr. LaGrange explained procedures of introduction of ordinances and expounded on the content of the proposed amendment to Ordinance No. 2216 which was adopted on April 22, 2020 relative to the creation of the Consolidated Gravity Drainage District No. 2A.

Rev. Mathews expounded on the death of George Floyd in Minneapolis.

Parish President, David Hanagriff reported that St. Mary Parish has had 30 COVID-19 related deaths and that Oschner St. Mary Hospital currently has one (1) positive COVID-19 patient; Franklin Foundation Hospital has 6 positive COVID-19 patients, all from Legacy of Franklin Nursing Home.

Mr. Ina encouraged Administration to continue to communicate with each other during the COVID-19 pandemic and the upcoming hurricane season.

Mr. Hanagriff reported that the Port of Morgan City held its first Virtual Hurricane Preparedness meeting on May 26, 2020 and expounded on items discussed.

Chief Administrative Officer, Henry “Bo” LaGrange, presented his report for a two (2) week period ending May 27, 2020.

Item 1 in Mr. LaGrange’s report stated, “Mr. Jeff Duhe, U. S. Census Bureau Louisiana Coordinator, has written to provide an update as of May 20, 2020 on the response to the 2020 Census in St. Mary Parish. Nationally, there has been a 59.5% self-response rate and in Louisiana the self-response rate is now at 54.5%. St. Mary Parish as a whole has improved its self-response rate from 44.1% to 47.4%, ranking St. Mary Parish 42nd amongst the 64 parishes. The response rates by municipality has increased since May 4th as follows:

Mr. Duhe asks that we continue to remind colleagues, friends, family and constituents that they can easily respond from home through the mail, computer, smart phone or regular voice phone. Item 2 in Mr. LaGrange’s report stated, “A Notice of Grant Award has been forwarded by Senator Cassidy’s office advising that St. Mary Parish has been awarded a grant in the amount of \$30,000 through the CARES Act for the Harry P. Williams Memorial Airport to provide economic relief funds for any purpose for which airport revenue may be lawfully used. A grant offer will be issued for this grant to be finally formulated in the near future.”

Item 3 in Mr. LaGrange’s report stated, “Patti Holland, TECHE Project, has written to provide an update on the TECHE Project Paddle Trail along Bayou Teche, more specifically the proposed trail dock at Schwan Park. An informational Kiosk will be installed this week and it is anticipated that a floating access dock will be fabricated and installed this fall for use by visitors traveling the Paddle Trail.”

In response to Mr. Ina’s inquiry, Mr. LaGrange stated that the Prairie Road Project is out for bid and that St. Joseph Road, Irish Bend Road, Baldwin, Charenton, and Four Corners area projects are on schedule.

In response to Mr. Adams’ inquiry relative to the Consolidated Gravity Drainage District No. 2’s proposed drainage project along LA 70, Mr. LaGrange stated that plans and specifications will be prepared and the project will be prepared for bid.

ORDINANCE NO.

An Ordinance creating a No-Wake Zone on Bayou Teche within one thousand five hundred feet upstream of the Katy Bridge and providing penalty for the violation thereof.

BE IT ORDAINED by the St. Mary Parish Council, on behalf of the St. Mary Parish Government, that the following be enacted:

SECTION 1. A no-wake zone is hereby designated along the on Bayou Teche within one thousand five hundred feet (1,500’) upstream of the Katy Bridge within which no person shall operate a motorboat, motor vessel, or recreational watercraft (hereinafter sometimes designated as “vessels” or “watercraft”) as follows:

- A. No person shall operate, cause to be operated, or permit to be operated, any motorboat, motor vessel, or recreational watercraft in such a manner or at such speed as may or shall create a wake from such operation. The term “wake” shall mean any vessel water turbulence in excess of six inches (6”) in wave height crest.
- B. Notwithstanding any other provision to the contrary, in no event shall the speed of a motorboat, motor vessel, or recreational watercraft exceed five (5) miles per hour.
- C. Waterskiing, jet skiing, and/or similar activities shall not occur in the designated no-wake zone.
- D. Appropriate signs shall be erected along the Charenton Drainage Canal. Any watercraft traveling on this canal shall respect the signs erected. Notwithstanding the provisions of this subsection, lack of such a sign shall not operate as a defense as to the application and enforcement of this Ordinance.

- E. This Ordinance shall not apply in instances where vessels are in navigational distress and power is essential for the proper control of the vessel in navigation for its safety and the safety of others or the safety of structures.
- F. For the purposes of this section, the registered owner of any such vessel or watercraft shall be presumed to be the operator of said vessel at the time the violation occurs.
- G. The Sheriff of St. Mary Parish and the State of Louisiana Department of Wildlife and Fisheries are hereby specifically requested and authorized to assist in the enforcement of the provisions of this section.

SECTION 2. Any person who violates the provisions of this Ordinance shall, upon conviction thereof, be punished by imprisonment in the St. Mary Parish Law Enforcement Center for a period of not more than thirty (30) days or a fine of not more than five hundred dollars (\$500.00) or by both such imprisonment and fine, at the discretion of the court. A second time offender will also have to attend a mandatory safe boating class.

SECTION 3. Any Ordinances, or parts of ordinances, in conflict herewith are hereby repealed.

This ordinance shall become effective and be in full force upon publication in the official journal of the Parish.

ORDINANCE NO.

An ordinance amending Ordinance No. 2216 adopted on April 22, 2020, by the Parish Council of the Parish of St. Mary, State of Louisiana, to provide for various terms of the creation of the Consolidated Gravity Drainage District No. 2A of the Parish of St. Mary, State of Louisiana authorized therein and providing for other matters in connection therewith.

WHEREAS, by Ordinance No. 2216 (the “Ordinance”), adopted on April 22, 2020, the Parish Council of the Parish of St. Mary, State of Louisiana (the “Parish Council”), as governing authority of the Parish of St. Mary, State of Louisiana (the “Parish”) creating Consolidated Gravity Drainage District No. 2A of the Parish of St. Mary, State of Louisiana (the “District”), describing the territory to compose the District and the proposed boundaries thereof, ordering and directing the publication of a notice of intention to create said District, and providing for the hearing of any and all objections to the creation thereof; and

WHEREAS, the Parish Council now desires to amend the Ordinance, specifically the language contained in Section 5 and Section 6 thereof, to provide with respect to the use of funds in and for the District; and

WHEREAS, capitalized terms used but not defined herein shall have the meaning given such terms in the Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Parish Council, acting as the governing authority of the Parish, that:

SECTION 1. Amendment of the Ordinance. Sections 5 and 6 of the Ordinance are hereby expressly replaced in their entirety with the following:

SECTION 5. CGDD2 and GDD6 shall continue in existence. Any existing taxes and service charges of both CGDD2 and GDD6 will remain in effect and continue to be collected. Such taxes and service charges or any other revenues heretofore or hereafter received by either CGDD2 or GDD6 shall be paid to the District and administered by the Board; however, the Board shall allocate all of the revenues from the existing taxes and service charges to the specific districts from which said revenues were derived. Notwithstanding the foregoing, any taxes levied by CGDD2 to pay general obligation bond debt service shall continue to be paid to CGDD2 and deposited in the sinking fund or funds established and maintained pursuant to the resolutions of CGDD2 issuing such general obligation bonds.

Additionally, any existing contracts of GDD6 and CGDD2 will remain in effect and continue to be performed. All contracts of GDD6 and CGDD2 that may be assigned shall be assigned to the District, and all contracts of GDD6 and CGDD2 that by specific terms therein or operation of law may not be assigned shall continue to be performed by the entity that entered into the original contract with the oversight and control of the Board.

SECTION 6. The entire proceeds of all funds collected or otherwise received by the District shall be used by the Board for gravity drainage purposes within the District as permitted pursuant to the Act. Any bond proceeds or revenues received pursuant to any grants or subject to any restrictions shall be used and accounted for in accordance with any applicable restrictions.

All funds received shall be promptly deposited in bank account(s) established and maintained with the regularly designated fiscal agent of the District, provided, however, any amount which is paid under protest or which is subject to litigation may be transferred to a separate account established by the Board pending the final determination of the protest or litigation.

SECTION 3. Effect of this Amending Ordinance. The Ordinance shall remain in full force and effect except as otherwise amended herein. Such amendments shall be effective as if initially contained in the Ordinance.

SECTION 4. Effective Date. This Amending Ordinance shall be in full force and effect immediately upon execution by the Parish President.
