NOTICE IS HEREBY GIVEN that the St. Mary Parish Council will hold a Public Hearing at 5:50 p. m. and will meet in Regular Session at 6:00 p.m. on Wednesday, September 12, 2018 in the Parish Council Meeting Room, Fifth Floor Courthouse, Franklin, Louisiana.

The purpose of the Public Meeting will be to receive written and/or oral comments and to adopt the following ordinances:

An Ordinance authorizing the Parish of St. Mary to enter into a Servitude and Right-of-Way Agreement with Jimmie B. Rogers and Cynthia V. Rogers related to Flattown Road.

An Ordinance amending and re-enacting Ordinance No. 2114 adopting the 2018 Combined Budgets of Revenues and Expenditures for the Parish of St. Mary, State of Louisiana.

An Ordinance providing policies and procedures for districts, agencies, boards, and commissions heretofore or hereafter created by the St. Mary Parish Council or its predecessor, the St. Mary Parish Police Jury; consolidating and delegating certain governmental functions of said districts, agencies, boards, and commissions; and providing for other matters in connection therewith.

An Ordinance to replace, amend, and re-enact Ordinance Nos. 2074, 2057, 1962, 1824, 1194, 1177, 1169, 1160 and 1128, establishing general rules and regulations to the code of ordinances relating to Board members, Commission members, and Advisory Board members policies for qualifications, filling vacancies, reporting requirements to the Parish Council, meeting rules and requirements and establishing enforcement and providing penalties for violation of this Ordinance.

An Ordinance to replace, amend, and re-enact Ordinance Nos. 743, 796, 1142, 1167, 1168, 1235, 1238, 1249, 1282, 1293, 1308, 1364, 1405, and 1458 establishing general rules and regulations and establishing fees for use of boat launch facilities, defining the manner in which user fees shall be dedicated, appointing caretakers to certain boat launch facilities and providing penalties for violation of this Ordinance.

An Ordinance to amend and re-enact Ordinance No. 1054 to redefine and revise the Representatives appointed to the Board of Commissioners of the 911 St. Mary Parish Communications District.

An Ordinance proposing an amendment to Sections 3-04, 3-07, and 3-10 of the Home Rule Charter for St. Mary Parish adopted February 1983.

An Ordinance proposing an amendment to Sections 2-05 of the Home Rule Charter for St. Mary Parish adopted February 1983.
